He has extensive insights of the operation of a commercial bank and a development bank with a dutiful passion in Islamic banking through his involvement in marketing, Islamic banking operation, Islamic trade financing, product development, system configuration and structuring of Islamic financing. He had been teaching for the past 18 years with the Open University, Business Administration faculty and was a regular examination moderator for INCEIF.

After the completion of the merger between OSK and RHB Investment Bank in 2013, he was reassigned to oversee the Islamic capital market function for the merged entity and later the overall non-retail business development of RHB Islamic Bank. Yazit holds a Master Degree in Business Administration majoring in Finance conferred by University of Southern Queensland, Australia in 2003.
